**LODGING: MANOR VAIL LODGE** is a full service ski lodge located across the street from the Golden Peak base lodge at the east end of Vail. The Manor Vail Lodge is about 50 yards/1 minute walk from the Riva Bahn Express lift (Chair 6) and less than 300 yards/7 minute walk from the Vista Bahn Express in Vail Village. An outdoor heated pool, hot tub, sauna & fully equipped exercise room are on the premises. The front desk is 24 hour with bell and concierge services available. Within the lodge are a restaurant - The Lord Gore - and a lounge - Fitzwilliam's. Room service is available nightly and they'll be glad to cater a dinner in your condo - the food is worth it! Après ski munchies and beverages are available with special deals on drinks and appetizers. Laundry facilities available. The free Vail bus service picks up across from the lodge. **Lodging choices** include double occupancy hotel rooms, studios, two bedroom, "two plus" bedroom or three bedroom condos. Standard occupancy is 2 persons per bedroom (and 1 in the sleeping area for the '2+). **If you need a roommate - lodging choices are limited to those with available beds - most likely availability is in hotel and 2+BR/3BA.** Standard occupancy is two persons per bedroom. Rooms booked at higher than standard occupancy will discount each person's trip price. **You must make up your own groups for higher than standard occupancy.** Condo configurations are subject to availability -- units/types will only be assigned when ALL roommates have their deposit and application in. 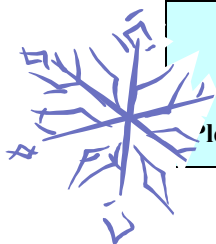

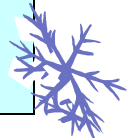
